Corrigendum

PROGRESS REPORT OF UNDP

This corrigendum is issued to:

- **Replace** the figures "62" **with** "60" and "37" **with** "31" on the 2nd and 3rd lines respectively in paragraph 7.
- **Replace** the first two sentences in paragraph 8 **with** the following:
 - 8. Implementation delays in countries such as China increased net ODS emissions in that country by 581 ODP tonnes and disbursements were 36 per cent of the amount planned. Other notable net emissions due to delays include Venezuela (327 ODP tonnes less were phased out than planned with 89 per cent of planned disbursements), Nigeria (219 ODP tonnes less were phased out and 161 per cent of planned funds disbursed), Lebanon (150 ODP tonnes less were phased out and 68 per cent of planned funds disbursements), and Costa Rica (85 ODP tonnes less were phased out and 22 per cent of planned disbursements).
- **Replace** NOU **with** national ozone unit at the last line of paragraph 25.
- Add "ongoing" between "42" and "RMP" to read "42 ongoing RMP activities" on the first line of paragraph 33.

- **Replace** the first sentence in paragraph 35 **with** the following:
 - 35. Four of the 9 ongoing end user incentive projects were approved at or after the 37th Meeting in July 2002. One of those four projects has a signed agreement with UNDP.
- **Replace** Recommendation 4 with the following:
 - 4. Note that the US \$9,121 disbursed from the US \$20,000 which was approved at the 36th Meeting to prepare foam projects in Libya (LIB/FOA/36/PRP/19) should be offset against the US \$40,000 received by UNIDO at the 38th Meeting to prepare a national ODS phase-out project (LIB/SEV/38/PRP/21) and request UNDP to provide all information collected and the project proposals to UNIDO following the 40th Meeting.
- **Replace** Annex I **with** the attached.
